House Votes This Week!

This Friday, the House of Representatives will vote on H.R. 3962, Nancy Pelosi's "Affordable Healthcare for America Act". This bill:

- Imposes a government-mandated insurance plan.¹
- Raises taxes.²
- Forces, unconstitutionally, all Americans to obtain insurance.³
- Burdens state governments.⁴
- Assaults the dignity of human life.⁵
- Fails to control cost inflation.⁶
- Increases premiums.⁷

I hope you will immediately activate your networks to target their U.S. Representative. The 435 members of the House must hear from their constituents. (Please do not contact a member or ask your networks to contact a member that does not specifically represent the person calling or emailing.)

While Nancy Pelosi's control of the U.S. House of Representatives remains undisputed, the sheer audacity of this bill provides conservatives a rare opportunity to find common ground with many legislators who usually vote for the liberal agenda. However, these congressmen are under intense pressure from their leadership to vote the party-line. Now is the time to activate your networks and get them involved in this very important fight for the future of our country.
